Nature Vs Nurture? No, it's Bias

The Science, Technology, Engineering and Math (STEM) fields will account for some of the fastest growing — and highest paying — jobs of the future. Yet girls and women are still not on par with boys and men in preparing for or entering into these fields.

Gender bias in school remains a significant barrier to girls' progress in STEM. Starting in early childhood, teachers and parents provide explicit and implicit messages that boys and men are "better" at math and science — although there is no evidence for that.

Girls have fewer role models in the STEM fields and fewer examples in media and popular culture. This reinforces stereotypes of these specialties as masculine. One study estimates that if girls had the same number of women inventor role models that boys have of male inventors, the gender gap in innovation could be cut in half.

A number of studies find that bias against women is the biggest obstacle keeping college women away from pursuing STEM degrees. Men vastly outnumber women majoring in many areas of math, science and technology. So it's no surprise that women make up only 28% of the STEM workforce.

A typical STEM worker earns two-thirds more than those employed in other fields. Giving women equal opportunities to pursue — and thrive in — STEM careers helps narrow the gender pay gap and enhance women's economic security. What's more, greater diversity also helps to banish biases, ensure a more talented STEM workforce and lead to a fuller range of the products and services that workforce produces.

What's happening in the Legibslature? Included are AAUW's comments and support or opposition to bills.

3/18/24 2:00 PM - Senate Elections, SHR 1 *HB2405-** Voter registrations; recorder; inactive status **COMMENT**: Permits the county recorders to place a person's voter registration information in inactive status and provide the person with notice of the action, if the County Recorder believes the person provided fraudulent or incorrect voter registration information. Too much discretion here- open to abuse. **OPPOSE**. Passed Senate Elections, awaiting hearing in Rules.

*****HCR2032** - Voting centers; precinct voting **COMMENT**: Unnecessary ballot referral, deliberately bypassing the Governor makes changes that will impact voters in vulnerable communities and populations. Forbids the use of voting centers and early voting locations in certain circumstances and eliminates most same day registration. **OPPOSE**. Passed, up in Rules 3/25. Recall, there is no public comment in Rules Committee.

3/21/24 9:00 AM - Senate Judiciary, SHR 1 HB2076- Domestic violence; definition; animal abuse **COMMENT**: Appears to be a good bill that deals with a tactic commonly utilized by abusers to terrify and intimidate their human victims. **SUPPORT**. Passed, awaiting hearing in Rules.

*****HB2310** - Grooming; classification **COMMENT**: Bill is overbroad, vague, and will criminalize sex education and other legitimate activity, as well as educators, librarians, and others. There are already many statutes which make it a crime to lure minors into sexual activity, and to sexually violate them. Police and Prosecutors have the tools they require, they need to use them. **OPPOSE**. Passed, awaiting hearing in Rules. **Ellie Watland Vice-President Public Policy**


